

# 2024-2025 VPK TUITION AGREEMENT

**TUITION** (PLEASE CHECK ALL THAT APPLY)

\_\_\_\_\_ **Half day K4 with VPK voucher (8:00-11:30)**

VPK Voucher – Must apply on line [www.vpkhelp.org](http://www.vpkhelp.org) by registration deadline and submit voucher to Children’s Rainbow Day School main office. Registration for full day is based on a yearly commitment. K4 Full day fees apply if VPK voucher is not received. *No tuition for half day students with voucher*

**Security fee per family** - \$300.00 (\$30.00 billed monthly)

**Registration & Activity Fee** - \$475.00 - This fee is due at the time of registration.

**Security fee per family** - \$300.00 (\$30.00 billed monthly)

**Tuition:** \$3,650.00 per year-payable in 10 payments of \$365.00 beginning August 1st and ending May 1st

\_\_\_\_\_ **Full day K4 without VPK Voucher**

\$6000.00 per school year – Payable in 10 payments of \$600.00 beginning August 1st and ending May 1st

**Registration & Activity Fee** - \$475.00 - This fee is due at the time of registration

**Security fee per family** - \$300.00 (\$30.00 billed monthly)

**Tuition** is due on the first of each month beginning August 1<sup>st</sup> and ending May 1<sup>st</sup>. Tuition is late after the 5<sup>th</sup> of the month and a late charge of **\$30.00** will be assessed. On the 10<sup>th</sup> day of the month, the student will not be admitted to class until tuition is paid in full. Tuition is divided into a 10-month payment plan. Therefore, a reduction cannot be granted when a child is absent, or when school is closed for holidays, staff conventions or severe weather. A \$40.00 Winter Supply Fee (per student) is due in January 2025. This fee helps to cover activities. **\$30.00** along with late fees (as stated above) will be charged for the first returned check or declined online payments/ **\$40.00** for 2<sup>nd</sup> returned payments / accounts will be on **cash only** basis after 2 returned payments in a school term.

**WITHDRAWAL:** The parent will notify the school in writing two weeks prior of a student’s withdrawal. The payment due for the month of disenrollment is payable in full. The parent understands this releases the school to place another student. No school records will be provided or forwarded for students whose account is in arrears.

Registration and Book Fees are non-refundable and non-transferable.
